



# ADULT PARTICIPANT AGREEMENT

## Equine

### (Including Acknowledgment and Assumption of Risks and Agreements of Release and Indemnity)

Please read this document carefully before signing. It contains important information about the equine program of Girls Scouts—Arizona Cactus Pines Council, Inc. (“the Council”) and affects the legal rights of participants in the program.

#### **AGREEMENT TO PARTICIPATE**

In consideration of being allowed to participate in this program, which is organized and conducted by the Council, Participant acknowledges and agrees as follows:

#### **Activities and Risks**

The program includes a variety of equine activities including: handling and caring for saddles, bridles and other tack and equipment and putting tack on the horses; walking, washing, brushing, cleaning hooves and otherwise moving about and caring for the horses; “control” and other games, on horseback; and riding in an enclosed ring, and riding on open trails over rough and uneven terrain, where obstacles on and above the ground may be encountered. These activities require moderate to strenuous physical activity.

Hazards and risks include, among others, the following: Horses are unpredictable in the best of circumstances. They may without apparent cause move into persons in their vicinity, bite, kick, rear, fall down, stumble, and bolt and run suddenly and with such force that even the strongest reining cannot stop them. They may react suddenly and violently to noise, movement, insects and other animals. Helmets are required while riding, but they cannot prevent falls and injuries, including to head, neck and spine. Other hazards of the equine activities include those associated with active recreation in an outdoor setting, including heat, cold, sleet and rain; slippery and uneven footing; falling and overhanging branches or limbs; poisonous and otherwise harmful insects, animals and plants; the carelessness and misjudgments of other participants and staff, and the failure of equipment; and collisions with other people and objects. Except in its summer resident programs, the Council contracts for the services of independent contractors to provide equine services. Participant agrees that he or she is solely responsible for any hospital, medical or other costs arising out of an injury or other loss sustained by or caused by Participant’s participation in activities of the Council. While the Council believes it has selected these contractors with care, the Council is not responsible for their acts or omissions in performing their services.

These and other risks and hazards are inherent in the equine programs and activities of the Council and cannot be eliminated without significantly changing the nature of the activities. Participant understands that these and other hazards and risks may result in loss or damage to personal property, and personal injuries, including falls, abrasions, sprains, breaks, and other emotional and physical injuries, and, in extreme cases even death.

Participant has no medical or emotional condition which may adversely affect his or her participation in these activities or cause Participant to be a danger to himself or herself or to others. Participant has described on the Adult Health Form provided by the Girl Scouts any and all medical conditions which he or she believes should be known to the Council. Participant understands that it is his or her sole responsibility to determine the Participant’s suitability, medical or otherwise, for the activities of the Council.

**Assumption of Risks**

Participant is aware of and understands the inherent risks of equine activities, including those described above, and accepts full responsibility for his or her safety and welfare. Participant acknowledges and assumes all risks of the activities and moving about the premises on which they are conducted, inherent or otherwise and whether or not described above.

**Agreements of Release and Indemnity**

Participant, to the maximum extent allowed by law, agrees to release and hold harmless the Council, its shareholders, directors, officers, employees, agents and contractors (“Released Parties”) from any and all claims which Participant may now have or acquire in the future, including claims of negligence (but not of gross negligence or intentionally wrongful conduct), as a result of or arising in any way from Participant’s enrollment or participation in this program or any activities of the Council.

Participant further agrees to protect and indemnify (that is, pay any judgments, costs, and attorney’s fees) the Council and the other Released Parties from any claim (including a claim of negligence of a released party but not of gross negligence or intentionally wrongful conduct) of any third party, including (but not limited to) rescuers, other participants in the activities of the Council and members of Participant’s family, arising from Participant’s enrollment or participation in activities of the Council.

Participant agrees that he or she is solely responsible for any hospital, medical or other costs arising out of an injury or other loss sustained by or caused by Participant’s participation in activities of the Council.

**Other**

Participant agrees to reimburse or pay any and all costs of the Council or any other Released Party associated with defending a claim brought by Participant, to the extent that claim is dismissed or otherwise found to be without merit.

In the event of a dispute between Participant and the Council or any other Released Party, Participant agrees that such dispute will be mediated in a good faith effort to resolve that dispute. Unless otherwise agreed in writing, any mediation or suit may be conducted or filed only in Maricopa County, Arizona, and the laws of Arizona will apply to any such dispute, excepting only the laws of the State of Arizona which may apply the laws of another jurisdiction.

Participant hereby consents to the provision of medical care in the event of an injury, illness or accident requiring medical attention during the activities of the Council. Parent further authorizes the Council to exchange with any third-party medical care giver such information regarding Participant’s medical history or conditions as may be deemed important to either of them.

Participant understands that the activities described herein and all aspects of them are purely voluntary and Participant may choose not to participate. The Council may use photographic or other images of Participant for marketing or any other purpose deemed reasonable by the Council.

This Agreement is intended to be binding, to the full extent of the law, on Participant and his or her estate and executor. If any part of this agreement is deemed by a Court of competent jurisdiction to be unenforceable, the remaining parts of the Agreement will remain in full force and effect. This agreement may be amended only in writing.
